Appendix 4 – Overview of Club Awards

Rev3: Updated 11 January 2024

The table below outlines the structure for the Club awards which are categorised in three key areas:

1. **Membership** – measured by the length of consecutive membership years with the Club.
2. **Participation Awards** – awarded for Motorsport participation only, with Sporting awards (Overall Champion, Class winners and Rookie of the Year) determined by results.
3. **Recognition Awards** – awarded on a discretionary basis for service to the Club and/or Chapters, initiated through nomination and supported with evidence of service and/or achievement. Discretionary Motorsport awards (Sportsmanship or Club Person of the Year, and novelty awards including the “Princey” Award and an Encouragement Award), are determined at the discretion of the Motorsport Chapter Captain.

CHAPTER CAPTAIN'S AWARD

1. The **Chapter Captain's award** is intended to be awarded annually to recognise outstanding service to each of the Club Chapters over the course of a Club Membership year.

The **Chapter Captain's award** is awarded at the absolute discretion of the relevant Chapter Captain.

The award may be presented to multiple winners in any given year, or a Chapter Captain may decide not to make any award.

2. In considering the presentation of the **Chapter Captain's award**, the following points shall be considered:
 - a. The Nominee shall have demonstrated an outstanding contribution to the relevant Chapter during the Club Membership year;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. There is no minimum period of membership required to be eligible for this award;
 - d. All current financial Club members, other than the incumbent Chapter Captain/s, are eligible for the award.
3. The Nominee shall not be informed of their nomination.
4. The Chapter Captain may seek the views of previous **Chapter Captain's award** recipients on the Nominee's worthiness of receiving the **Chapter Captain's award**, but the final decision is the Chapter Captain's alone.
5. Recipient(s) are announced at the Annual General Meeting or an alternate Club event of eminent status.
6. The physical recognition of the award will be a **Chapter Captain's award** trophy.



IN APPRECIATION AWARD

1. The **In Appreciation Award** is awarded as recognition of a Valued Contribution or Valued Support for the Club. The **In Appreciation Award** may be awarded to multiple winners in any given year.
2. In considering the presentation of the **In Appreciation award**, the following points shall be considered:
 - a. The Nominee shall have demonstrated a Valued Contribution or Valued Support for the Club;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club, as expressed in the Club's Statement of Purposes and Rules;
 - c. There is no minimum period of Club Membership required to be eligible for this award;
 - d. There is no minimum period of contribution and/or support required to be eligible for the award;
 - e. All current financial Club members are eligible for the award;
 - f. Non-financial Club members or organisations are also eligible for the award.
3. A Valued Contribution could include, but is not limited to:
 - Contribution to Club activities – eg, Club runs, NatMeet Organising Committee, *mxtra* etc.
 - Participation in the Club governance roles, including Committee, Chapters and other non-official roles.
4. Valued Support could include, but is not limited to:
 - Support of the Club through Sponsorship and/or Advertising.
 - Support of the Club through in-kind support.
 - Support that contributes to a positive reflection of the Club and its members.
5. The Nominee shall not be informed of their nomination.
6. The **In Appreciation Award** is awarded if the Committee unanimously endorses the nomination. The assessment of the entire Committee shall be sought, not simply the Committee meeting attendees. Committee member(s) may choose to abstain, in which case it will not impede a unanimous decision.
7. If the Committee does not unanimously endorse the Nominee, the Nominator/s shall be informed of the decision in writing by the President or Secretary. The nomination may be resubmitted after a minimum period of 12 months from the date of the decision.
8. If the Nominee is a current Committee member, they will be excluded from the Committee's assessment of the nomination. To retain the anonymity of the nomination, the Committee may choose to seek the endorsement of other Committee members outside the normal business of the Committee meeting.
9. Recipient(s) are announced at the Annual General Meeting or an alternate Club event of eminent status.
10. The physical recognition of the award will be an **In Appreciation** trophy.



JINBA ITTAI AWARD

1. **Jinba Ittai** is Mazda's expression for the "*oneness between rider and horse*" in relation to the experience of driving the Mazda MX-5.

The **Jinba Ittai award** is awarded annually as recognition of the "*oneness between a Club member and the Club*", presented to a member or members who have provided outstanding service to the Club over the course of a Club Membership year.

It is, in effect, an annual discretionary President's award.

The **Jinba Ittai award** is awarded at the absolute discretion of the Club President.

The award may be presented to multiple winners in any given year, or the President may decide not to make any award.

2. In considering the presentation of the **Jinba Ittai award**, the following points shall be considered:
 - a. The Nominee shall have demonstrated an outstanding contribution to the Club during the Club Membership year;
 - b. The general attitude and overall demeanour of the Nominee reflects a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. There is no minimum period of membership required to be eligible for this award;
 - d. All current financial Club members, other than the incumbent President, are eligible for the award.
3. The Nominee shall not be informed of their nomination.
4. The President may seek the views of previous **Jinba Ittai award** recipients on the Nominee's worthiness of receiving the **Jinba Ittai award**, but the final decision is the President's alone.
5. Recipient(s) are announced at the Annual General Meeting or an alternate Club event of eminent status.
6. The physical recognition of the award includes a suitable Jinba Ittai Award trophy and a Club Jinba Ittai metal lapel pin.

SERVICE AWARD

1. The **Service Award** is awarded as recognition of Diligent Service to the Club for a member who has been actively involved in Club activities on a continual basis. The **Service Award** may be awarded to multiple winners in any given year.
2. In considering the presentation of a **Service Award**, the following points shall be considered:
 - a. The Nominee shall have demonstrated Diligent Service for the Club;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. The recipient of this award will have completed a minimum period of three years of Club Membership to be eligible for this award;
 - d. All current financial Club members are eligible for the **Service Award**.
3. Diligent Service could include, but is not limited to:
 - Contribution to Club activities – eg, Club runs, NatMeet Organising Committee, *mxtra* etc for a period in excess of three years.
 - Participation in the Club governance roles, including Committee, Chapters and other non-official roles for a period in excess of three years.
4. Any financial member can nominate a member for a **Service Award**. Nominations must demonstrate how the Nominee meets the above criteria and shall be submitted in writing to the Club President or Club Secretary for consideration by the Committee.
5. The Nominee shall not be informed of their nomination.
6. The **Service Award** is awarded if the Committee unanimously endorses the nomination. The assessment of the entire Committee shall be sought, not simply the Committee meeting attendees. Committee member(s) may choose to abstain, in which case it will not impede a unanimous decision.
7. If the Committee does not unanimously endorse the Nominee, the Nominator/s shall be informed of the decision in writing by the President or Secretary. The nomination may be resubmitted after a minimum period of 12 months from the date of the decision.
8. If the Nominee is a current Committee member, they will be excluded from the Committee's assessment of the nomination. To retain the anonymity of the nomination, the Committee may choose to seek the endorsement of other Committee members outside the normal business of the Committee meeting.
9. Recipient(s) are announced at the Annual General Meeting or an alternate Club event of eminent status.
10. The physical recognition of the award will be a metal **Service Award** lapel pin.



SERVICE STAR

1. The **Service Star** is awarded as recognition of Dedicated Service to the Club, usually over many years and often in a variety of roles and activities. It stands above the **Service Award** and may be a further recognition for a member who already holds a **Service Award**. The **Service Star** may be awarded to multiple winners in any given year.
2. In considering the presentation of a **Service Star**, the following points shall be considered:
 - a. The Nominee shall have demonstrated Dedicated Service for the Club;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. The recipient of this award will have completed a minimum period of five years of Club Membership to be eligible for this award;
 - d. All current financial Club members are eligible for the **Service Star**, provided they have previously received the Service Award.
3. Dedicated Service could include, but is not limited to:
 - Contribution to Club activities, eg, Club runs, NatMeet Organising Committee, *mxtra*, etc. for a period in excess of five years.
 - Participation in the Club governance roles, including Committee, Chapters and other non-official roles for a period in excess of five years.
4. Any financial member can nominate a member for a **Service Star**. Nominations must demonstrate how the Nominee meets the above criteria and shall be submitted in writing to the Club President or Club Secretary for consideration by the Committee.
5. The Nominee shall not be informed of their nomination.
6. The **Service Star** is awarded if the Committee unanimously endorses the nomination. The assessment of the entire Committee shall be sought, not simply the Committee meeting attendees. Committee member(s) may choose to abstain, in which case it will not impede a unanimous decision.
7. If the Committee does not unanimously endorse the Nominee, the Nominator/s shall be informed of the decision in writing by the President or Secretary. The nomination may be resubmitted after a minimum period of 12 months from the date of the decision.
8. If the Nominee is a current Committee member, they will be excluded from the Committee's assessment of the nomination. To retain the anonymity of the nomination, the Committee may choose to seek the endorsement of other Committee members outside the normal business of the Committee meeting.
9. Recipient(s) are announced at the Annual General Meeting or an alternate Club event of eminent status.
10. The physical recognition of the award will be a metal **Service Star** lapel pin.



HONORARY MEMBERSHIP

1. **Honorary Membership** can be awarded to supporters and past Club members in recognition of long-term support of the Club.
2. **Long-term support for the Club** could be as a supporter (eg, non-member partner of an active member), sponsor or advertiser, or a past member who continues to provide support for the Club, Committee or Chapter.
3. The views of existing Life Members, Hall of Fame Members and Club Legends on the Nominee's worthiness to become an Honorary Member may be taken into consideration by the Committee when assessing the nomination.
4. This membership can be awarded at any time by a majority vote of the Club Committee.
5. **Honorary Life members** enjoy the same rights as Full members and adult Family members of the Club. Please see the next category in this Appendix for separate details on Honorary Life membership.
6. **Honorary members** (ie, other than Honorary Life members) do not have voting rights, and may not use this category of membership for the purpose of obtaining a Motorsport Australia [formerly CAMS], AASA or other form of motorsport competition licence, or Club Permit registration.
7. Physical recognition of the award includes an **Honorary Member** name badge.



HONORARY LIFE MEMBERSHIP

1. **Honorary Life Membership** is awarded for long-term service to the Club. A nominee must have given Exceptional Service to the Club, by the application of extraordinary expertise, dedication and positive influence. It is a significant award and may only be conferred on a Club member at the absolute discretion of the Committee in exceptional circumstances.
2. In considering the awarding **Honorary Life Membership**, the following points shall be considered:
 - a. The Nominee shall have demonstrated Exceptional Service to the Club;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. The recipient of this award will have completed a minimum period of 10 years of membership to be eligible for this award;
 - d. All current financial Club members are eligible for the award, provided they have previously received the Service Star.
3. Exceptional Service could include, but is not limited to:
 - Contribution to Club activities – eg, Club runs, NatMeet Organising Committee, *mxtra*, etc. for a period in excess of seven years.
 - Participation in the Club governance roles, including Committee, Chapters and other non-official roles for a period in excess of seven years.
4. Any two financial members can nominate a member for **Honorary Life Membership**. Nominations must demonstrate how the Nominee meets the above criteria and shall be submitted in writing to the Club President or Club Secretary for consideration by the Committee.
5. The Nominee shall not be informed of their nomination.
6. The views of existing **Life Members** on the Nominee's worthiness to become a **Life Member** may be taken into consideration by the Committee when assessing the nomination.
7. **Honorary Life Membership** is awarded if the Committee unanimously endorses the nomination. The assessment of the entire Committee shall be sought, not simply the Committee meeting attendees. Committee member(s) may choose to abstain, in which case it will not impede a unanimous decision.
8. If the Committee does not unanimously endorse the Nominee, the Nominator/s shall be informed of the decision in writing by the President or Secretary. The nomination may be resubmitted after a minimum period of 12 months from the date of the decision.
9. If the Nominee is a current Committee member, they will be excluded from the Committee's assessment of the nomination. To retain the anonymity of the nomination, the Committee may choose to seek the endorsement of other Committee members outside the normal business of the Committee meeting.
10. Recipient(s) are announced at the Annual General Meeting or an alternate Club event of eminent status.
11. Physical recognition of the award includes a framed certificate, **Life Member** metal lapel pin, mounted model MX-5 and **Life Member** name badge.
12. Recognition of Honorary Life Membership will be accompanied by a citation on the Club's **Life Membership** Honour Roll.



MAZDA MX-5 CLUB OF VICTORIA & TASMANIA HALL OF FAME

1. Induction to the **Mazda MX-5 Club of Victoria & Tasmania Hall of Fame** will only be conferred on a Club member at the absolute discretion of the Committee.

Hall of Fame recognition stands above **Honorary Life Membership** and recognises individuals who have made a Remarkable Contribution to the Club.

Nominees of this award must have demonstrated duration of services rendered, significant achievement at the highest level and a voluntary contribution to the Club which stands out above all others.

Induction to the **Hall of Fame** is only to be awarded in highly exceptional circumstances and, as such, induction to the **Hall of Fame** should be guided by a proposed ratio of one Hall of Fame inductee for every five Honorary Life Members.

2. Eligibility for induction into the **Hall of Fame**, should consider the following points:
 - a. The Nominee shall have demonstrated a Remarkable Contribution to the Club;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. The recipient of this award will have completed a minimum period of 15 years of membership to be eligible for this award;
 - d. The member is already an **Honorary Life Member**.
3. Remarkable Contribution could include, but is not limited to:
 - Contribution to Club activities – eg, Club runs, NatMeet Organising Committee, *mxtra*, etc. for a period in excess of 10 years.
 - Participation in the Club governance roles, including Committee, Chapters and other non-official roles for a period in excess of 10 years.
4. Any two financial members can nominate a member for the **Hall of Fame**. Nominations must demonstrate how the Nominee meets the above criteria and shall be submitted in writing to the Club President or Club Secretary for consideration by the Committee.
5. The Nominee shall not be informed of their nomination.
6. The views of existing **Hall of Fame** inductees on the Nominee's worthiness to become an inductee to the **Hall of Fame** may be taken into consideration by the Committee when assessing the nomination.
7. If the Nominee is a current Committee member, they will be excluded from the Committee's assessment of the nomination. To retain the anonymity of the nomination, the Committee may choose to seek the endorsement of other Committee members outside the normal business of the Committee meeting.
8. Induction to the **Hall of Fame** is awarded if the Committee unanimously endorses the nomination. The assessment of the entire Committee shall be sought, not simply the Committee meeting attendees. Committee member(s) may choose to abstain, in which case it will not impede a unanimous decision. If the Committee does not unanimously endorse the Nominee, the Nominator/s shall be informed of the decision in writing by the President or Secretary. The nomination may be resubmitted after a minimum period of 12 months from the date of the decision.

10. A **Hall of Fame** framed certificate, a **Hall of Fame** metal lapel pin and **Hall of Fame** name badge. are the physical recognition of the award.
11. Recognition of **Hall of Fame** will be accompanied by a citation on the Club's **Hall of Fame** Honour Roll.



MAZDA MX-5 CLUB OF VICTORIA & TASMANIA CLUB LEGEND

1. **Mazda MX-5 Club of Victoria & Tasmania Club Legend** recognition is the highest award available. It recognises an Extraordinary Contribution of an individual to the Club and may only be conferred on a Club member at the absolute discretion of the Committee.

Nominees of this award must have demonstrated duration of services rendered, significant achievement at the highest level and a voluntary contribution to the Club which has had an enduring legacy for the Club.

Club Legend recognition is only to be awarded in extraordinary circumstances and, as such, awarding **Club Legend** status should be guided by a proposed ratio of one Club Legend for every three Hall of Fame inductees.
2. Eligibility for **Club Legend** recognition should consider the following points:
 - a. The Nominee shall have demonstrated an Extraordinary Contribution to the Club;
 - b. The general attitude and overall demeanour of the Nominee reflect a dedication to the values of the Club as expressed in the Club's Statement of Purposes and Rules;
 - c. The recipient of this award will have completed a minimum period of 20 years of membership to be eligible for this award;
 - d. The member is already an inductee to the **Hall of Fame**.
3. Extraordinary Contribution could include, but is not limited to:
 - Contribution to Club activities – eg, Club runs, NatMeet Organising Committee, *mxtra*, etc for a period in excess of 15 years.
 - Participation in the Club governance roles, including Committee, Chapters and other non-official roles for a period in excess of 15 years.
4. Any two financial members can nominate a member for **Club Legend** recognition. Nominations must demonstrate how the Nominee meets the above criteria and shall be submitted in writing to the Club President or Club Secretary for consideration by the Committee.
5. The Nominee shall not be informed of their nomination.
6. The views of existing **Club Legend** inductees on the Nominee's worthiness to become an inductee as the **Club Legend** may be taken into consideration by the Committee when assessing the nomination.
7. Induction to the **Club Legend** status is awarded if the Committee unanimously endorses the nomination. The assessment of the entire Committee shall be sought, not simply the Committee meeting attendees. Committee member(s) may choose to abstain, in which case it will not impede a unanimous decision.
8. If the Committee does not unanimously endorse the Nominee, the Nominator/s shall be informed of the decision in writing by the President or Secretary. The nomination may be resubmitted after a minimum period of 12 months from the date of the decision.
9. If the Nominee is a current Committee member, they will be excluded from the Committee's assessment of the nomination. To retain the anonymity of the nomination, the Committee may choose to seek the endorsement of other Committee members outside the normal business of the Committee meeting.
